 - Would need to have rural and small community forums at the same time.
 - These forums would need to be moderated.

BUSINESS ARISING FROM THE MINUTES

NEW BUSINESS

1. UBCM report on responsible conduct – UBCM Executive Director Gary MacIsaac and UBCM Director of Communications Paul Taylor

- A working group comprised of LGMA, the Province and UBCM developed a variety
 of tools to help with relationships, deal with issues and sanctions, if necessary, at the
 local council/board level.
- Procedural fairness is very important
- A lot of councils have adopted code of conducts but a lot of these have "no teeth", ie no enforcement.
- Courts won't remove elected officials from office
- Best approach for Local Governments is to focus on prevention (including education, collaboration, and shared responsibility) and informal solutions (which allow for mutual resolutions, fairness and allow the process for resolution to move more quickly)
- Local Governments have an option to hire an independent 3rd party to vet a complaint in a fair and transparent manner
- Councils/boards need to learn to work together even when members disagree
- The principles in a code of conduct will be embedded in the oath of office for new elected officials after the upcoming elections.
- Should there be a code of conduct for citizens addressing elected officials??
- **2.** EComm 911 presentation Julie Decker, Director, Operations Relationship Management and Jasmine Bradley, Executive Director Communications and Public Affairs
 - Federally mandated modernization of a 40-year-old technology
 - Voice service launch March 2022
 - Texting ability by July 2023
 - Decommission of old network by March 2025
 - 911 now has the ability to pinpoint exactly where the call is originating
 - Current property owners pay for this service which is not fair as 80% of calls come from cell phones
 - City of Vancouver has submitted a resolution to establish a new mandate with proposed financial changes. SILGA will write a letter to support this resolution.

- As at May 31, 2022 SILGA had \$73,424 in the bank and \$83,926 in the MFA account. SILGA has \$114,400 of accessible funds.
- Membership dues invoices have been sent out and 24 communities have paid already.
