UBCM REPORT:

Aimee: November quarterly meeting - this term had strat planning, helpful.

Resolutions process discussion – how to make equitable so that smaller RDs can pass their motions too – LGAs need to help by combining similar resolutions to help them pass at UBCM Code of conduct and ongoing files – Aimee is Indigenous Relations Vice-Chair, also on Health and Social Development Committee – UBCM site has a public version of the November meeting Spencer: resolutions was the biggest conversation

Strategic planning: threats to UBCM, someone brought up that the LGAs' strength threatens UBCM – took exception to the comment – this attitude is something to keep in mind Louise: sitting on Economic Development and Convention Committees

FCM REPORT:

Went to Ottawa: focus on communications strategy and upcoming election Louise gave a brief update of FCM occurrences

Spencer will lead three board members to draft a public statement concerning US tariffs.

EXECUTIVE COMMUNITY UPDATES

- 1. Bill Sarai Kamloops past board refresh: as Chair Roden said, Indigenous rep is important, future consideration for inviting neighbouring groups to join meetings regardless of acceptance find ways to include meaningfully instead of just 'as guest'
- 2. Tricia Thorpe TNRD EA Zoom meeting Mon Jan 20 chance to pick topics for group discussion and collaborate across RDs second one so far working with 5 FN bands in Lytton area Fire trailer from Steveston rotary first time that unincorporated community and 5 FN bands are cooperating to take care of each other video coming out about lack of insurance for wildfires by RogersTV features last year's impacted regions RDs don't have ready access like municipalities to insurance
- 3. Adam Etchart Merritt is developing 286 spring improvements planning new furniture warehouse being built trying to attract mobile home business
- 4. Isaac Gilbert Penticton Valley Frost Fest update on housing 2024, 629 development approvals and more impending
- 5. Aimee Grice Oliver Oliver, supporting local physicians recruitment working group to address ER/GP shortages: regional group w members from Osoyoos, key barrier: housing. IH has donated land to make travelling healthcare worker homes (halfway point while looking for housing) working with Minister Osborne to get funds new marketing plan Doctors on committee too
- 6. Tasha Da Silva West Kelowna final stages of West Kelowna Economic Development corporation Tasha is director! looking for other directors and hiring a CEO at Merrit convention: wish for Economic Development to be represented
- 7. Keith Thom Peachland affordable housing 72 units for seniors peachlanders first instead of BC housing 104 space daycare centre will break ground in April w gov grant!
- 8. Spencer Coyne Princeton new fire hall being built, flood mitigation plans, \$6 million water upgrade, \$2 million sewer upgrade, new housing and social housing for seniors, private infrastructure too Copper Mountain Mine now has over 910 employees, more than projected
- 9. Stephen Kamloops Red bridge burnt, lost connection to t'kemlups (their bridge) planning session started to rebuild fire resiliency and firesmart initiatives starting this spring: reconciliaction, working with Indigenous knowledge keepers to burn off grasslands that threaten Kamloops since this is a refuge place for many during the fire season insurance is something SILGA might consider for an educational seminar since Rob Sweitzer has been working with the US forest service and other agencies Kamloops has a volunteer fire hall for 23% of the community considered 'rural' looking to staff it better to protect those people and reduce insurance costs needs SILGA attention because insurance will increase in light of climate change alternate approval process for capital builds is in court; 10 people are holding up breaking ground on art centre and rink complex due to process issues: frustrating lots of new stuff in Kamloops! hoping to get a sounding board on SILGA that all communities can contribute to so we can keep an eye across all our representative regions and coordinate knowledge use website? need to know parameters and difference in governance systems between SILGA and Indigenous groups to increase collaboration looking forward to future discussion
- 10. Louise Salmon Arm apartment buildings have been approved: more in the past year than in the past 10-12yrs combined! hopeful all will make it to market working through OCP creation, which occurs once every 5 years emerging SILGA issue: how to facilitate OCPs actually getting implemented
