**CALL TO ORDER**

President Louise Wallace Richmond called the regular board meeting to order at 10:37am.

**COMMUNITY UPDATE**

Staff Darren Caul presented on Kelowna's advocacy concerning The city's advocacy paper on Chronic Offenders. Seeing increased investments in community safety across North America: rising costs, particularly RCMP (105% increase) are unsustainable, however, Kelowna crime is down 18% 2022-24. Still, public trust is waning, creating social disorder.

What is a chronic offender? Minority of offenders responsible for most crime. 2024 – 15 individuals accounted for 1,335 police files in Kelowna (89/person average). Incredibly complex because intersects with addiction, brain injury, and homelessness. This approach may focus on accountability but acknowledges we need a multiplicity of intervention paths.

Community impacts? Public, police, prosecution adapt: all three need to do their part, and if the public does not trust the others, that erodes the foundation. Crown prosecutors are too few to handle these cases. Lower-level crimes (ones that are more noticed by the public, like petty theft) are getting triaged and that means cases are being dismissed. Technical procedures for police have also increased, yet they still need to keep their timelines within those prescribed by the Province. 12% decrease in BC incidents but a 43% decrease in charge rates nationally: 6% decrease in incidents and 11% decrease in charge rates (lowest since 2019). Incarceration rates lowest since 2019.

Focus: Kelowna wants to deal with repeat property crime offenders differently than others and is pushing changes via federal bail reform. The proposed legislation currently in Ottawa has been impacted by Kelowna's advocacy, but there is still a need to examine the number of offenses an individual has because people who will not show up to court and who will commit new offenses within days, if not hours, are being let out.

Of course, bail reform is not a silver bullet: we need comprehensive supports. This should, however, help reduce bureaucratic backlog that is overworking our police and prosecution systems. We also need more crown prosecutors across all Local Governments in BC.

Stephen Karpuk commented that the courthouse consolidations that occurred did not coincide with an expansion of remaining courthouse services, increasing the issues: a major point of concern for Kamloops who is now servicing Ashcroft, Williams Lake, and Merritt, to name a few.

Many major policy changes have not come with the infrastructure changes needed to set them up for success.

Kelowna requests that this be highlighted in SILGA's advocacy as a unifying issue for the Southern Interior. Solidarity concerning this issue at this timely federal juncture will support the bail initiative alongside having the Province step up re: prosecutor employment. There are currently no analytics for what the reasonable amount of work is for a crown prosecutor. The threshold for prosecution is also higher than any other region in Canada.

**Interest in presenting at SILGA 2026** concerning this item, as well as submitting a Board resolution.

BC Crown must determine charges because RCMP cannot. This is a good thing, but it is also an added workload. Alberta just changed to the proposed policy last year, so Kelowna is studying their workload statistics.

Kelowna has begun educating the public on this issue: these papers illuminate that the problem is on the province and federal government/the crown; the police do not approve charges.

RCMP/Crown Prosecutors are not at liberty to speak up about this; SILGA's role can be to add to the voices. Federal government is working on bail reform, so now we need the province to step up and provide crown prosecutors.
